Treasurer's Report

- General account \$70,945.63 (\$16K invoice outstanding)
- Casino account \$95,038.04 (\$6K invoice outstanding)
- Outstanding invoices are for Foothills on remaining work to be done on the deck
- New casino funds will arrive in November
- FCC will have audited statements ready for AGM

Community Developments

- Deck is open, space is great, no complaints from neighbours to date
- Waiting on framers to finish posts so stone work can be done
- Railing needs some reinforcing
- Staying roughly on budget
- We have paid approximately \$31K, outstanding invoice \$6K plus \$23K for framing and stonework
- 3 new development files, a few meetings have been scheduled, overall about ½ number of applications as 2011 but more difficult discussions re: lower MR development

Community Events

- Wine & cheese (Sept 8) went well with 85 people in attendance
- Current licensing only allows 77 people for liquor consumption
- Clean-up was criticized by Sunday morning renters; Debra and Tina handled the situation as best as possible
- Walking Tour Thanks to Megan and Al, great turnout
- BBQ great event, over 300 people, lots of work due to learning curve re: permits
- Highlanders community to supply coffee/refreshments
- Progressive Dinner set for Oct 20th, no confirmed houses yet
- Possibility of a December event depending on Progressive dinner success

Newsletter:

- Hard deadline for next newsletter is Sept 12th in order to get it delivered by October
- 2013 deadlines Jan 12, May 12, Sept 12
- Theme for this month finish historic houses, HMRB update
- Next projects/people in the neighborhood
- Great comments on last newsletter have we considered different publisher even though Glencoe does it for free? Glencoe is very slow

Membership

- Currently 330 members
- Will finish drive next year
- Current members will be sent a renewal invoice early next year
- Marlene is resigning

Facilities

- Security system is for water and smoke only
- Skateboarders appear to have moved on from our park
- Signage has gone up
- Tennis court door is broken again, there were no takers for lessons this summer

HMRB

- Focus this year was on graffiti and gardens
- Most of the gardens have disappeared except South MR park
- Only 3 volunteers showed up for spring clean up
- Fall clean up schedule for Sept 15th
- City considering rocks for end of Prospect at 14th street to minimize illegal turns
- Roads will put bushes in strategic spots on Premier traffic circle to deter illegally driving across circle
- Royal ave buttons will be properly landscaped with shrubs
- Met with city re: taking over mgmt of parks, HMRB will discuss with other communities currently using this model

Upcoming year – bring in more resilient plants, reduce # and size of beds in South MR
Park, work with city re: Elm trees, put together a catalogue of our spaces and a plan to
manage them, cleanup unnamed parkland and glencoe hill, 2014 is 100 years of parks
so maybe a commemorative event, establishing a subcommittee on public art and the
available grant money, collecting oddball bits of MR history (ie. Elm tree planted by
William Reader at south end of Amhearst at Prospect)
